BYLAW C-1425

**A Bylaw to Establish User Fees for the
Eastlink Centre and Grande Prairie Outdoor Pool during
the COVID-19 pandemic**

(As Amended by Bylaw C-1425A)

WHEREAS, pursuant to Section 7 of the Municipal Government Act, RSA 2000, Chapter M-26, Grande Prairie City Council may pass bylaws for municipal purposes respecting services provided by or on behalf of a municipality;

WHEREAS, the Council of the City of Grande Prairie has enacted the Fees, Rates and Charges Bylaw C-1395;

AND WHEREAS, in order to alleviate the financial impact on residents in light of the COVID-19 pandemic, and modified accessibility to all of the Multiplex Aquatics and Wellness (Eastlink Centre) amenities and the Grande Prairie Outdoor Pool, Council wishes to amend the User Fee in Bylaw C-1395 for the Eastlink Centre and the Grande Prairie Outdoor Pool until regular operations are permitted to resume;

AND WHEREAS, to alleviate extensive waitlists for private bookings at the Grande Prairie Outdoor Pool and provide further modified accessibility at both the Grande Prairie Outdoor Pool and Eastlink Centre during the extended Government of Alberta Re-launch Strategy Stage 2 during the COVID-19 pandemic.

NOW THEREFORE, THE COUNCIL OF THE CITY OF GRANDE PRAIRIE, IN THE PROVINCE OF ALBERTA, DULY ASSEMBLED, ENACTS AS FOLLOWS:

1. This Bylaw shall be called the “COVID-19 Eastlink Centre and Grande Prairie Outdoor Pool User Fee”.
2. Eastlink Centre Drop-in User Fee will be charged at \$5.00 per person, per visit, until regular operations are permitted to resume.
 - 2 a) Eastlink Centre Lazy River cohort booking private rental will be charged at \$100.00 per 60 minute booking, until regular operations are permitted to resume.

 - 2 b) Eastlink Centre Splash Pad cohort booking private rental will be charged at \$100.00 per 60 minute booking, until regular operations are permitted to resume.
(Bylaw C-1425A - August 10, 2020)
 - 2 c) Eastlink Centre Lazy River and Splash Pad (combined amenities) for cohort booking private rental will be charged at \$150.00 per 60 minute booking, until regular operations are permitted to resume.

 - 2 d) Eastlink Centre Waterslides, add on fee only, to any aforementioned cohort booking private rental aquatic amenity will be charged at \$50.00 per 60 minute booking, until regular operations are permitted to resume.

2 e) Eastlink Centre Family hot tub OR Adult hot tub, add on fee only, to any aforementioned cohort booking private rental will be charged at \$50.00 per 60 minute booking, until regular operations are permitted to resume.

2 f) Eastlink Centre Concourse North side including stationary bikes cohort booking private rental will be charged at \$100.00 per 60 minute booking, until regular operations are permitted to resume.

2 g) Eastlink Centre Concourse South side including the “Synrgy 180”, multi-functional weight training apparatus, cohort booking private rental will be charged at \$100.00 per 60 minute booking, until regular operations are permitted to resume.

3. Eastlink Centre Membership Fee will be charged at \$50.00 per person, per month, until regular operations are permitted to resume.

4. Grande Prairie Outdoor Pool Drop-in User Fee for the Grande Prairie Outdoor Pool will be charged at \$5.00 per person, per visit, until regular operations are permitted to resume.

5. Grande Prairie Outdoor Pool Booking Fee will be charged \$100.00 per 45 minute booking, and \$125.00 per 60 minute booking, until regular operations are permitted to resume.

5 a) Grande Prairie Outdoor Pool Booking Fee will be charged at \$50.00 per 30 minute cohort booking private rental, until regular operations are permitted to resume.

6. That Council delegate rate setting authority for the Eastlink Centre and the Grande Prairie Outdoor Pool to Administration, until regular operations are permitted to resume.

7. Except as modified by this Bylaw all other aspects of the Fees, Rates and Charges Bylaw C-1395 are in force as enacted.

8. This Bylaw shall take effect on the date it is passed.

READ a first time this 29 day of June, 2020.

READ a second time this 29 day of June, 2020.

READ a third time and finally passed this 29 day of June, 2020.
