- The treatment of each payment shall be the same as if I/we had personally issued a cheque authorizing payment as indicated and to debit the amount specified to my/our account.
- Any payments returned by the bank for **ANY REASON** are subject to a **SERVICE CHARGE**. This payment must be made paid within 10 days of the return date to avoid **CANCELLATION FROM THE PLAN**.
- This authorization may be cancelled by the **20th of each month with written notice**.
- This authorization will automatically renew your tax payments. **You do not have to reapply each year**.
- For an account where more than one person has to sign cheques, **all depositors must sign this application**
- In the event of a sale of the above noted property or a change in your bank account, it is your responsibility to immediately provide written notification to the Tax Dept at City Hall.
- Your tax payments start in January of each year. If you are not signed up before December 31st, you can now sign up throughout the year. To do this, payments must be brought up to date and there is a late sign up fee if done after December 31.
- **This authorizes your payments to be changed twice a year.** January through May's payments will be an estimated amount. June through December's payment will be recalculated and divided over the last seven months of the year based on the actual tax levy outstanding in order to bring your account to a zero balance.
