- Modular units are moved
- \$1.2 M approved for unforeseen items such as structural, lighting, landscaping
- Total current cost of the CCC is \$23.25 MIL

- Recognizing the City's choice to raise the Treaty 8 and Metis Flags in council chambers the flags will be a permanent addition. There was a Pipe ceremony before the Flag Ceremony
- National Truth and Reconciliation Day in Muskoseepi Park Seot 30th. 8 a.m. Pipe Ceremony and at 9:30 a.m. will be a Walk/Run. Lunch and Dinner are served in the park along with entertainment
- On October 4th, the GPFC will hold a walk to recognize Missing and Murdered Indigenous Women and Girls ("MMIWG") Day of Action.
- City of GP attended Treaty Days in Horse Lake First Nations, Sturgeon Lake Cree Nation, and Duncan's First Nation
- Ohcîwin- Pow Wow Regalia installation by Patrick Mitsuing is still in the Grande Prairie Art Gallery until October 8<sup>th</sup>.
- Evacuees from the Northern Territory have returned home. While they were here, the City of Grande Prairie took additional measures to ensure that culturally significant events were held for the northern Dene community. Some of the events were Feed the Fire Ceremony and Drum Dancing. GPFC and NWP also held events that were culturally significant for the Dene such as Tea Dances and Dene Drumming
